- 2. I have given my consent to act as Scrutinizer vide letter dated 21st May, 2025.
- 3. The Board had authorized the Company Secretary & Compliance Officer to be responsible for the entire postal ballot process and also authorized him to do all things and to take all incidental and necessary steps for smooth conduct of the entire postal ballot process.
- 4. Pursuant to the provisions of Sections 108, 110 and other applicable provisions, if any, of the Companies Act, 2013 ("the Act") read with Rule 20 and 22 of the Companies (Management and Administration) Rules, 2014 ("the Rules"), Regulation 44 of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations"), and the Secretarial Standard-2 on General Meetings issued by the Institute of Company Secretaries of India ('SS-2'), read with General Circular Nos. 14/2020 dated April 8, 2020, 17 /2020 dated April 13, 2020 and various subsequent circulars, read with latest Circular No. 9/2024 dated September 19, 2024 issued by the Ministry of Corporate Affairs ("the MCA Circulars") and any other applicable provisions, of the Act, Rules, Regulations, Circulars and Notifications (including any statutory modification(s), clarification(s) or re-enactment(s) thereof for the time being in force), the items of special business as set out in the Notice were proposed for approval of the Members of the Company through Postal Ballot by way of electronic voting (remote e-voting) process only.
- 5. In compliance with the MCA Circulars, the Notice including Explanatory Statement along with the instructions of remote e-voting was sent by email on 23<sup>rd</sup> May, 2025 only to those members who had registered their email address with the Company or Depositories/Depository Participants/Registrar and Transfer Agent (RTA) and whose names appeared on the Register of Members/List of Beneficial Owners as received from National Securities Depository limited {"NSDL") and Central Depository Services (India) limited ("CDSL") as on the cut-off date i.e. Friday, 16<sup>th</sup> May, 2025. The Members of the Company as on the cut-off date were entitled to vote on the Resolution as contained in the Notice.
- 6. The Company had published an advertisement in newspapers (Financial Express all editions in English and Pratahkal Mumbai edition in Marathi) on **24**<sup>th</sup> **May**, **2025** regarding completion of dispatch of Notice and also specifying therein the matters prescribed in the Rules with regard to remote e-voting.
- 7. The Company had appointed CDSL for providing remote e-voting facility to the Members of the Company.
